



ALE Release Notes : June 19, 2020

New Features

1. Add new checkbox field to Monthly Progress Review for Cert Teacher to record "Monthly Progress Reviewed With Student"
2. Surface new columns (hidden by default) on Monitor Monthly Progress Screen to track parent receipt of Monthly Progress and/or review of monthly progress with student by Certificated Teacher
3. Add All Classes link to left nav for Parent role with read only access
4. Registrar now has a toggle in the Schedule Class page that will allow classes available for enrollment to be filtered to "All Classes" (for override purposes) or "Filter to SLP" to view those that match the SLP criteria
5. Initial development of Librarian role and associated functions/features
6. Added new field to allow Student to provide input for Monthly Progress on a per course basis

Configurations/Updates

1. Planner view now allows for scheduling of classes up to 8:59 pm (default view displays until 4:00 pm but updates to hour needed upon scheduling)
2. Update new navigation bar to include an "ALE" icon which allows users to easily navigate back after leaving the ALE application
3. SLP Details tab: captures both "earliest approval date" and "most recent approval date"
4. On Subject/Course tab of SLP, the Core Subject Area Courses column pinned to left to make viewing associated data easier
5. On "Link Student to ALE" page:
 - a. Filter to subdomain created in
 - b. Add row action gear that allows for deleting records
6. Update WSLP Subjects/Courses" feature to "back-apply" changes made in course record to all active WSLPs updated to include changes made to Default Certificated Teacher and Course Code
7. Update Class details tab with new field to allow for capturing Learning Credit cost per class meeting
8. Registrar role:
 - a. Add "All Class Meetings" page in "Courses/Classes" to allow for removal of individual class meetings or by date range
 - b. Update "Create Plan" interface to include grade level pulled from SIS and other established defaults
 - c. Update parent group selector to include column for student name and also to pull in students based on future enrollments

9. Data Admin Role:
 - a. Add Mass Copy Classes by Year feature
10. Secretary role:
 - a. ALE Users Management page added to left nav for managing account permissions
 - b. Manage Enrollment Percentages page updated with new editable Estimated Hours field tied directly to Student Learning Plan
11. Parent Role:
 - a. Limited fields available to edit on Proposed Course to the following fields: Course Name, Description, District Approved Curriculum, Instructional Materials, Learning Activities, Evaluation and Timelines

Bug Fixes

1. Course Description field is again displaying on Course Details tab
2. Updates to print WSLP buttons so that all produce district-specific versions rather than defaults
3. Surface data table on "Scheduled Classes" tab in Manage Course for Certificated Teacher
4. Update the Subject/Courses table on SLP to allow for display of each course individually for districts utilizing enrollment method 2 (where corresponding subject/course records are automatically generated upon enrolling in Classes)
